

Golf Link - Membership Loyalty Offer

Terms and Conditions: 2017

1. This offer is open only to Golf Link members (being golfers who have a "Golf Link" membership account with Golf Link Partners Pty Ltd ABN 95 081 497 154) (**Members**). The offer applies to private buyers and persons acquiring vehicles for business or commercial purposes only. Fleet buyers, government authorities and agencies, call 1800228844 for more details.

2. The offer commences on Sunday 1st January 2017 at 00:01 (AEST) and expires Saturday 30th December 2017 at 23:59 (AEST) (**Offer Period**). The offer may not be combined with any other offer or promotion run by Hyundai and is not transferable. The offer can only be redeemed once per vehicle purchase.

3. There are two stages to the offer.

Stage 1 – Purchase of one of the following new Hyundai vehicle models by a Golf Link Member from an authorised Hyundai dealer within the Offer Period:

- Genesis
- Genesis with Sensory Pack
- Genesis with Ultimate Pack

(a) The Member can purchase any of the above new Hyundai Genesis vehicles (**Vehicle**) from any authorised Hyundai Genesis dealer at any price during the Offer Period.

(b) Second hand or demonstration vehicles are excluded from the offer.

(c) Members will not be required to identify themselves as a member of Golf Link at the time of purchase of the Vehicle.

4. How to claim the Loyalty Bonus:

(a) Following the purchase and registration of the Vehicle, the Member can complete the Member Offer Redemption Form (**Redemption Form**) on the Golf Link website:

They will be required to complete the following fields:

- First Name
- Surname
- Phone Number
- Email Address
- Dealership Name
- Car Registration
- Registration Date
- Driver's License No.

(b) Upon completion of the entry form, the Member will receive an email from redemption@genesishgolflinkcup.com.au, requesting that the Member either post or email supporting documentation to the following email address or postal address:

Supporting documentation includes:

- (i) A copy of their driver's licence;
- (ii) Vehicle registration papers; and
- (iii) A copy of the sale contract for the purchase of the Vehicle.

The name of the Member must be identical to the name contained in the sale contract and the registration papers, unless vehicle is registered under company name or ABN. For vehicle purchased under company name or ABN, the member must be the authorizing name on the contract.

(c) Upon verification of valid membership and supporting documentation of the Member, Hyundai will arrange to credit the member's Golf Club account with \$1000.

(d) Hyundai and or Golf Link will not be responsible for any Redemption Forms or supporting documentation that becomes lost in the mail, during transmission or are received by Golf Link illegible, damaged or corrupt.

(e) The Redemption Form must be completed and supporting documentation received by Golf Link within 3 months of the date of purchase of the Vehicle. Hyundai and or Golf Link will not accept any claims or pay any Loyalty Bonus if the Redemption Form and/or supporting documentation are received by Golf Link after the 3-month period.

(f) The Member is only entitled to the Loyalty Bonus if the person is a Member of Golf

Link at the time of purchase and delivery of the Vehicle, which must be within the Offer Period. Upon receipt of the Redemption Form and supporting documentation, Golf Link will verify the identity of the Member and whether they comply with these terms and conditions at the time of purchase and delivery of the Vehicle.

(g) Within a reasonable time of verification of identity and valid membership of the Member, Hyundai will arrange a credit to Member's Golf Club account for the amount of the applicable Loyalty Bonus.

(h) Hyundai and or Golf Link reserves all rights to refuse or reject any redemptions for the Loyalty Bonus if Hyundai or Golf Link, in their discretion, determines or is of the reasonable opinion, that the claimant does not meet or comply with these terms and conditions.

5. Members under the age of 18 must obtain the written permission of a parent or guardian over the age of 18 to redeem under this offer.

6. Incomprehensible, illegible, corrupt or incomplete Redemption Forms and supporting documents will be deemed invalid.

Both Hyundai and Golf Link reserve the right to request Members to provide any additional proof of identity, proof of purchase of a Vehicle or other evidence Hyundai or Golf Link requires to establish the validity of the claimant's Loyalty Bonus redemption, and to reject any redemption for the Loyalty Bonus if the claimant is unable to satisfy any such requests to the extent Hyundai and or Golf Link requires in its discretion.

Hyundai and or Golf Link reserves the right to reject any redemptions if Hyundai and or Golf Link suspects that the claimant has tampered with the redemption process, a claimant submits a redemption that is not in accordance with these Terms and Conditions or the claimant has, in the opinion of Hyundai and or Golf Link, engaged in conduct in making the redemption which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of Hyundai and or Golf Link.

9. The Loyalty Bonus or the legal or beneficial interest in the Loyalty Bonus cannot be transferred or assigned and cannot be redeemed for anything other than payment by a credit to the Member's Golf Club account, which can take 8 weeks to process.
